You will need to **complete at least one retrofit** that is both eligible and recommended by your energy advisor.

**Book your post-retrofit evaluation and apply for reimbursement.**

Once you have completed your home retrofits, book your post-retrofit evaluation and submit all your required documents online or by mail.

## ELIGIBLE RETROFITS

### Home Insulation up to \$5,000

Update your eligible attic/ceiling, exterior wall, exposed floor, basement or foundation, and crawlspaces.

### Air Sealing up to \$1,000

Perform air sealing to improve the air-tightness of your home to achieve the air-change rate target.

### Windows and Doors up to \$5,000

Replace your windows or glass doors with ENERGY STAR® certified models. **You must keep the ENERGY STAR stickers on the windows until the post-retrofit evaluation OR take 2 pictures of every window; one of the sticker and one of the window to show its placement in the wall.**

### Thermostats up to \$50

Add a smart thermostat to help improve your comfort and save money on your energy bill (**must be combined with another retrofit**).

### Heating up to \$5,000

Make the switch to more energy-efficient heating equipment to save on your utility bill and reduce your carbon footprint. **Homeowners must consult with their HVAC contractor to make sure the selected heat pump is sized appropriately and listed as one of the eligible systems. The Greener Homes program requires the system to be capable of distributing heat to the entire home, but the sizing of the system should be performed by a professional.**

### Renewable Energy up to \$5,000

Install photovoltaic solar panels to convert sunlight energy into electricity. **The Energy Advisor will require details on the PV system installed from the installer, including array size, azimuth, and system efficiencies.**

Incentives to protect your home and your family from environmental damages (**must be combined with another retrofit**).

### Small Multi-Unit Residential Buildings

**IMPORTANT: Receipts are required for every upgrade performed and homeowners are responsible for submitting these receipts onto the homeowner portal.**

Homeowners are only eligible for grant amounts equal to or less than the amount paid for the upgrade, up to the maximum listed grant amount (i.e. If the air sealing invoice adds up to \$200, the maximum grant amount is \$200.)

Homeowners should confirm all equipment they are planning to install qualifies for a rebate by consulting with the [Greener Homes website](#).
